

**MEADOWBROOK HEIGHTS METROPOLITAN DISTRICT
2025 ANNUAL REPORT
JEFFERSON COUNTY, COLORADO**

Pursuant to Section VII. C. of the Service Plan (“Service Plan”) of the Meadowbrook Heights Metropolitan District (the “District”), and pursuant to Section 32-1-207(3)(c), C.R.S., the District is required to submit an Annual Report (“Annual Report”) to the County of Jefferson and the Jefferson County Clerk of the Board of County Commissioners, no later than August 1st of each year. The District hereby submits the following Annual Report for the year ending December 31, 2025 (the “Reporting Year”).
